

MY GENDER GENIE (GENDER GENIE)

TERMS AND CONDITIONS OF TRADE

1. Definitions

- 1.1 "Gender Genie" or "My Gender Genie" or "Little Lunar" means any legal entity of Gender Genie and any current or future holding company, subsidiary, related company or successors and assignees of these companies or any person acting on behalf of and with the authority of the Gender Genie.
- 1.2 "Company" refers to any legal entity of Gender Genie and any current or future holding company, subsidiary, related company or successors and assignees of these companies or any person acting on behalf of and with the authority of the Gender Genie.
- 1.3 "Customer" means the person/s buying the Goods and/or Services or Services as specified in any invoice, document or order, and if there is more than one Customer is a reference to each Customer jointly and severally.
- 1.4 "Confidential Information" means any information exchanged between Gender Genie and the Customer for the purposes of the Customer buying the Goods and/or Services from Gender Genie, including but not limited to, the prices and payment terms offered to the Customer by Gender Genie.
- 1.5 "Goods" means all Goods supplied by Gender Genie to the Customer (and where the context so permits, shall include any supply of Services as hereinafter defined) and are as described on the invoices, quotation, work authorisation or any other forms as provided by Gender Genie to the Customer. Goods includes the Lunar Conception Map.
- 1.6 "Lunar Conception Map" refers to the chart derived from a prospective mother and father's birthdates which indicate when conception could occur that may increase the chance of having a baby of a particular sex.
- 1.7 "Services" means all Services supplied by Gender Genie to the Customer and includes any advice or recommendations (and where the context so permits, shall include any supply of Goods and/or Services as defined above).
- 1.8 "Price" means the Price payable for the Goods and/or Services as agreed between Gender Genie and the Customer in accordance with clause 4 below.
- 1.9 "Website" means https://mygendergenie.com/ or https://gendergenie.com/ or https://gendergeni
- 1.10 "Terms" means these Terms and Conditions which constitute the legally binding agreement between Gender Genie and the Customer for the provision of Gender Genie Goods and/or Services.
- 1.11 "Permitted Purpose" means the purchase of the Goods and/or Services from Gender Genie.

2. Acceptance

- 2.1 The Customer is taken to have accepted and is immediately bound, jointly and severally, by these Terms if the Customer places an order for or accepts delivery of the Goods and/or Services from Gender Genie.
- 2.2 Electronic signatures shall be deemed to be accepted by either party providing that the parties have complied with Section 9 of the *Electronic Transactions Act 2000* (Vic) or any other applicable provisions of that Act or any Regulations referred to in that Act.



3. Gender Genie Does Not Provide Medical Advice

3.1 The information contained within this website, Gender Genie's social media, the Lunar Conception Map and any other information in any other medium conveyed by Gender Genie are for entertainment purposes only and is not intended to replace medical advice or treatment or provide health information.

4. Gender Genie does not guarantee any outcomes

4.1 Gender Genie does not guarantee that a baby will be born a particular sex if conception accords with the suggestions of the personalised Lunar Conception Map. Gender Genie will not be responsible for any disappointment stemming from the birth of a child of a particular sex. The use of any information provided by Gender Genie is at the sole discretion and risk of the customer.

5. The Customer Takes All Liability

- 5.1 Whilst the formula used to generate the Lunar Conception Map is supported by anecdotal evidence, no outcome is scientifically guaranteed. Under no circumstances will Gender Genie accept liability to any extent for any injury, loss or damage stemming from decisions made on the basis of information provided on this website or the Lunar Conception Map.
- 5.2 Gender Genie does not make any express or implied warranties, guarantees or representations about any information presented by Gender Genie, regardless of the medium upon which it is published.
- 5.3 Any information followed by a customer is at their own risk entirely. The customer who purchases the Lunar Conception Map accepts sole liability for any decisions and actions they make upon receipt of the information conveyed by Gender Genie.
- 5.4 This site and service is not to be used by children under the age of 18.

6. Change in Control

6.1 The Customer shall give Gender Genie fourteen (14) days prior written notice of any proposed change of ownership of the Customer and/or any other change in the Customer's details (including but not limited to, changes in the Customer's name, address, contact phone, email or fax number/s, or business practice). The Customer shall be liable for any loss incurred by Gender Genie as a result of the Customer's failure to comply with this clause.

7. Orders and Price

- 7.1 At the sole discretion of Gender Genie, the Price shall be either:
 - (a) as indicated on any invoice provided by Gender Genie to the Customer; or
 - (b) the Price as at the date of delivery of the Goods and/or Services according to the current price list of Gender Genie.
- 7.2 Unless otherwise stated the Price does not include GST. In addition to the Price, the Customer must pay to Gender Genie an amount equal to any GST Gender Genie must pay for any supply by Gender Genie under this or any other agreement for the sale of the Goods and/or Services. The Customer must pay GST, without deduction or set off of any other amounts, at the same time and on the same basis as the Customer pays the Price. In addition, the Customer must pay any other taxes and duties that may be applicable in addition to the Price except where they are expressly included in the Price.



- 7.3 Gender Genie will not accept an order unless the order has been delivered to Gender Genie with specific details included. Gender Genie does not accept responsibility for any Customer's details being incorrectly entered into the Website or App which may or may not alter the outcome of the Lunar Conception Map.
- 7.4 Where any orders are given by the Customer verbally, Gender Genie will not accept any responsibility for miscommunicated request information under any circumstances.
- 7.5 Once the order is placed by the Customer and has been accepted by Gender Genie, the Customer will be unable to cancel the order unless Gender Genie provides written acceptance of the cancellation.

8. Payment

- 8.1 Time for payment for the Goods and/or Services being of the essence, the Price will be payable by the Customer on the date/s determined by Gender Genie, which is:
 - (a) before delivery of the Goods and/or Services; or
 - (b) other form or agreement which has been agreed, in writing, between the parties as being the date for payment.
- 8.2 Payment may be made by online transaction at the time of purchase to receive delivery of the Lunar Conception Map.

9. Delivery of Goods

- 9.1 Delivery ("Delivery") of the Goods and is taken to occur at the time that Gender Genie delivers the Goods to the Customer's nominated email address.
- 9.2 The Customer must take delivery by of the Goods.
- 9.3 Any time or date given by Gender Genie to the Customer is an estimate only, and Gender Genie will not be liable for any disruptions to delivery due to unavoidable circumstances, including but not limited to, internet service disruption, employee strikes and natural disasters. The Customer must still accept delivery of the Goods even if late and Gender Genie will not be liable for any loss or damage incurred by the Customer as a result of the delivery being late.

10. Risk

- 10.1 Risk of damage to or loss of the Goods passes to the Customer on Delivery.
- 10.2 Any risk inherited by the Customer on Delivery is particularised in the Terms of Use policy. To the extent of any inconsistencies between these Terms and Conditions and the Terms of Use, the Terms of Use shall prevail.

11. Title

- 11.1 Gender Genie and the Customer agree that ownership of the Goods shall not pass until:(a) the Customer has paid Gender Genie all amounts owing to Gender Genie; and(b) the Customer has met all of its other obligations to Gender Genie.
- 11.2 Receipt by Gender Genie of any form of payment other than cash shall not be deemed to be payment until that form of payment has been honoured, cleared or recognised.
- 11.3 It is further agreed that:
 - (a) until ownership of the Goods passes to the Customer in accordance with clause 8.1 that the Customer is only a bailee of the Goods and must return the Goods to Gender Genie on request and delete the original and any copies of the Lunar Conception Map;



- (b) The Customer must not sell, dispose, or otherwise part with possession of the Goods other than in the ordinary course of business and for market value. If the Customer sells, disposes or parts with possession of the Goods then the Customer must hold the proceeds of any such act on trust for Gender Genie and must pay or deliver the proceeds to Gender Genie on demand;
- (c) The Customer should not convert or process the Goods or intermix them with other Goods but if the Customer does so then the Customer holds the resulting product on trust for the benefit of Gender Genie and must sell, dispose of or return the resulting product to Gender Genie as it so directs;
- (d) Gender Genie may recover possession of any Goods in transit whether or not delivery has occurred; and
- (e) Gender Genie may commence proceedings to recover the Price of the Goods sold notwithstanding that ownership of the Goods has not passed to the Customer.

12. Security and Charge

- 12.1 In consideration of Gender Genie agreeing to supply the Goods and/or Services to the Customer, the Customer charges all of its rights, title and interest (whether joint or several) in any land, realty or other assets capable of being charged, owned by the Customer either now or in the future, to secure the performance by the Customer of its obligations under these terms and conditions (including, but not limited to, the payment of any money).
- 12.2 The Customer indemnifies Gender Genie from and against all Gender Genie costs and disbursements including legal costs on a solicitor and own client basis incurred in exercising Gender Genie rights under this clause.
- 12.3 The Customer irrevocably appoints Gender Genie and each director of Gender Genie as the Customer's true and lawful attorney/s to perform all necessary acts to give effect to the provisions of this clause 9 including, but not limited to, signing any document on the Customer's behalf.

13. Intellectual Property

- 13.1 Where Gender Genie has designed, drawn or developed Goods for the Customer, then the copyright in any designs and drawings and documents shall remain the property of Gender Genie.
- 13.2 The Customer warrants that all designs, specifications or instructions given to Gender Genie will not cause Gender Genie to infringe any patent, registered design or trademark in the execution of the Customer's order and the Customer agrees to indemnify Gender Genie against any action taken by a third party against Gender Genie in respect of any such infringement.
- 13.3 The Customer agrees that Gender Genie may (at no cost) use for the purposes of marketing or entry into any competition, any documents, Lunar Conception Maps, designs, drawings or Goods which Gender Genie has created for the Customer.

14. Defects, Warranties and Returns, Competition and Consumer Act 2010 ("CCA")

14.1 The Customer must inspect the Goods and/or Services on delivery and must within five (5) days of delivery notify Gender Genie in writing of any evident defect/damage, shortage in quantity, or failure to comply with the description or quote. The Customer must notify any other alleged defect in the Goods and/or Services as soon as reasonably possible after any such defect



becomes evident. Upon such notification the Customer must allow Gender Genie to inspect the Goods and/or Services.

- 14.2 Gender Genie Goods and/or Services come with guarantees that cannot be excluded under the Australian Consumer Law. For major failures with the Services, the Customer is entitled:
 - (a) to cancel your Services contract with us; and
 - (b) to a refund for the unused portion, or to compensation for its reduced value.

The Customer is also entitled to choose a refund or replacement for major failures with Goods and/or Services. If a failure with the Goods and/or Services and/or Services does not amount to a major failure, the Customer is entitled to have the failure rectified in a reasonable time. If this is not done, the Customer is entitled to a refund for the Goods and/or Services and to cancel the contract for the Services and obtain a refund of any unused portion. The Customer is also entitled to be compensated for any other reasonably foreseeable loss or damage from a failure in the Goods and/or Services and/or Services ("Non-Excluded Guarantees").

- 14.3 Gender Genie acknowledges that nothing in these Terms purports to modify or exclude the Non-Excluded Guarantees.
- 14.4 Except as expressly set out in these Terms or in respect of the Non-Excluded Guarantees, Gender Genie makes no warranties or other representations under these Terms including but not limited to the quality or suitability of the Goods and/or Services. Gender Genie liability in respect of these warranties is limited to the fullest extent permitted by law.
- 14.5 If the Customer is a consumer within the meaning of the CCA, Gender Genie liability is limited to the extent permitted by section 64A of Schedule 2.
- 14.6 If Gender Genie is required to replace the Goods and/or Services under this clause or the CCA, but is unable to do so, Gender Genie may refund any money the Customer has paid for the Goods and/or Services.
- 14.7 If the Customer is not a consumer within the meaning of the CCA, Gender Genie liability for any defect or damage in the Goods and/or Services is:
 - (a) limited to the value of any express warranty or warranty card provided to the Customer by Gender Genie at Gender Genie sole discretion;
 - (b) limited to any warranty to which the Gender Genie is entitled, if Gender Genie did not manufacture the Goods and/or Services;
 - (c) otherwise negated absolutely.
- 14.8 Subject to this clause 11, returns will only be accepted provided that:
 - (a) The Customer has complied with the provisions of clause 11.1; and
 - (b) Gender Genie has agreed that the Goods and/or Services are defective; and
 - (c) the Goods and/or Services are returned within a reasonable time at the Customer's cost (if that cost is not significant); and
 - (d) the Goods and/or Services are returned in as close a condition to that in which they were delivered.
- 14.9 Notwithstanding clauses 14.1 to 14.8 but subject to the CCA, Gender Genie shall not be liable for any defect or damage which may be caused or partly caused by or arise as a result of:
 - (a) the Customer failing to properly maintain or store any Goods and/or Services;
 - (b) the Customer using the Goods and/or Services for any purpose other than that for which they were designed;



- (c) the Customer continuing the use of any Goods and/or Services after any defect became apparent or should have become apparent to a reasonably prudent operator or user;
- (d) the Customer failing to follow any instructions or guidelines provided by Gender Genie; or
- (e) fair wear and tear, any accident, or act of God.
- 14.10 Gender Genie will not accept returns of any products delivered via email, regardless of whether which the customer has opened the email.
- 14.11 Notwithstanding anything contained in this clause, if Gender Genie is required by a law to accept a return, then Gender Genie will only accept a return on the conditions imposed by that law.
- 14.12 Subject to clause 11.1, customised, or non-stocklist items or Goods and/or Services made or ordered to the Customer's specifications are not acceptable for credit or return, including the Map.

15. Default and Consequences of Default

- 15.1 Without prejudice to any other remedies Gender Genie may have, if at any time the Customer is in breach obligation (including those relating to payment) under these terms and conditions Gender Genie may suspend or terminate the supply of Goods and/or Services to the Customer. Gender Genie will not be liable to the Customer for any loss or damage the Customer suffers because Gender Genie has exercised its rights under this clause.
- 15.2 Without prejudice to Gender Genie other remedies at law Gender Genie shall be entitled to cancel all or any part of any order of the Customer which remains unfulfilled and all amounts owing to Gender Genie shall, whether or not due for payment, become immediately payable if:
 - (a) any money payable to Gender Genie becomes overdue, or in the opinion of Little Lunar the Customer will be unable to make a payment when it falls due;
 - (b) the Customer becomes insolvent, convenes a meeting with its creditors or proposes or enters into an arrangement with creditors, or makes an assignment for the benefit of its creditors; or
 - (c) a receiver, manager, liquidator (provisional or otherwise) or similar person is appointed in respect of the Customer or any asset of the Customer.

16. Cancellation

- 16.1 Gender Genie may cancel any contract to which these Terms apply or cancel delivery of Goods and/or Services at any time before the Goods and/or Services are delivered by giving written notice to the Customer. On giving such notice Gender Genie shall repay to the Customer any money paid by the Customer for the Goods and/or Services. Gender Genie shall not be liable for any loss or damage whatsoever arising from such cancellation.
- 16.2 If the Customer cancels delivery of Goods and/or Services the Customer shall be liable for any and all loss incurred (whether direct or indirect) by Gender Genie as a direct result of the cancellation.
- 16.3 Cancellation of orders for Goods and/or Services made to the Customer's specifications, or for items not contained on the stock list, will not be accepted once production has commenced, or an order has been placed.

17. Privacy Policy



17.1 A copy of the Privacy Policy, updated from time to time, of Gender Genie can be found at https://mygendergenie.com/ or alternatively, a hard copy can be provided upon written request.

18. Unpaid Gender Genie Rights

- 18.1 Where the Customer has left any item with Gender Genie for repair, modification, exchange or for Gender Genie to perform any other service in relation to the item and Gender Genie has not received or been tendered the whole of any moneys owing to it by the Customer, Gender Genie shall have, until all moneys owing to Gender Genie are paid:
 - (a) a lien on the item; and
 - (b) the right to retain the item, such sale to be undertaken in accordance with any legislation applicable to the sale or disposal of uncollected Goods and/or Services.
- 18.2 The lien of Gender Genie shall continue despite the commencement of proceedings, or judgment for any moneys owing to Gender Genie having been obtained against the Customer.

19. Service of Notices, Legal Demands and Process

- 19.1 Any written notice or legal demand given under this contract shall be agreed to have been given and received:
 - (a) by handing the notice or legal demand to the other party, in person;
 - (b) by leaving it at the address of the other party as specified during user registration or as otherwise specified in writing by the other party;
 - (c) by sending it by registered post to the address of the other party as stated during user registration or as otherwise specified in writing by the other party;
 - (d) if sent by facsimile transmission to the fax number of the other party as stated during user registration, on receipt of confirmation of the transmission;
 - (e) if sent by email to the other party's email address as specified during user registration.
- 19.2 Any notice or legal demand that is posted shall be deemed to have been served, unless the contrary is shown, at the time when by the ordinary course of post, the notice would have been delivered.

20. Trusts

- 20.1 If the Customer at any time upon or subsequent to entering in to the contract is acting in the capacity of trustee of any trust ("Trust") then whether or not the Customer may have notice of the Trust, the Customer covenants with Gender Genie as follows:
 - (a) the contract extends to all rights of indemnity which the Customer now or subsequently may have against the Trust and the trust fund;
 - (b) the Customer has full and complete power and authority under the Trust to enter into the contract and the provisions of the Trust do not purport to exclude or take away the right of indemnity of the Customer against the Trust or the trust fund. The Customer will not release the right of indemnity or commit any breach of trust or be a party to any other action which might prejudice that right of indemnity;
 - (c) the Customer will not without consent in writing of Gender Genie (Gender Genie will not unreasonably withhold consent), cause, permit, or suffer to happen any of the following events:
 - (i) the removal, replacement or retirement of the Customer as trustee of the Trust;
 - (ii) any alteration to or variation of the terms of the Trust;



- (iii) any advancement or distribution of capital of the Trust; or
- (iv) any resettlement of the trust property.

21. Confidentiality

- 21.1 The Customer agrees that it will keep the Confidential Information confidential and:
 - (a) use its best endeavours to prevent disclosure of the Confidential Information to any third parties unless the prior written consent of Gender Genie has been obtained;
 - (b) not claim any legal, equitable or beneficial interest in the Confidential Information and warrants that any Confidential Information it receives will be used solely for the Permitted Purpose; and
 - (c) not use the Confidential Information in any manner which may be directly or indirectly detrimental or cause loss to Gender Genie.
- 21.2 On written request of Gender Genie:
 - (a) return to Gender Genie all documents, disks and other computer media and all other material in the possession or control of the Customer which may contain or be derived from ideas, concepts, creations which are related to the Confidential Information or which are related to the Permitted Purpose;
 - (b) delete/destroy all copies of Confidential Information which cannot for practical considerations be returned to the Gender Genie; and
 - (c) take steps to identify the Confidential Information and separate it from other documents stored by the Customer. In the event that the Confidential Information is disclosed and such disclosure is not in accordance with these Terms, the Customer will provide written notice to the recipients (or potential recipients) that the information is of a confidential nature and must not be utilised by those third parties in any manner without the Disclosing Party's prior written consent.
- 21.3 The Customer agrees and acknowledges that the Confidential Information is of a proprietary and confidential nature and that any breach of these Terms pursuant to clause 18.1, by the Customer would cause irreparable injury or damage to Gender Genie which may not be capable of remedy by monetary damages alone.
- 21.4 If Gender Genie becomes aware of a breach or anticipated breach of clause 18.1 (or has reasonable grounds to suspect that such breach will occur) the Customer agrees that in addition to all other rights available to Gender Genie pursuant to these Terms, at law and/or in equity to make a claim for loss and/or damage suffered.

22. General

- 22.1 These terms and conditions and any contract to which they apply shall be governed by the laws of the State of Victoria, Australia and each party submits to the non-exclusive jurisdiction of the courts in the State of Victoria, Australia.
- 22.2 Neither party shall be liable for any default due to any act of God, war, terrorism, strike, lockout, industrial action, fire, flood, storm or other event beyond the reasonable control of either party.
- 22.3 The Customer warrants that it has the power to enter into this agreement and has obtained all necessary authorisations to allow it to do so, it is not insolvent and that this agreement creates binding and valid legal obligations on it.



- 22.4 The Customer agrees that Gender Genie may amend these terms with five (5) business days written notice. Provided the Customer does not notify Gender Genie of any rejection or alternation of the proposed amendment within five (5) business days of receiving the written notice, the Customer will be taken to have accepted such changes.
- 22.5 The failure by Gender Genie to enforce any provision of these Terms shall not be treated as a waiver of that provision, nor shall it affect Gender Genie right to subsequently enforce that provision. If any provision of these terms and conditions shall be invalid, void, illegal or unenforceable the validity, existence, legality and enforceability of the remaining provisions shall not be affected, prejudiced or impaired.
- 22.6 Subject to clause 11, the liability of Gender Genie shall be limited to damages which under no circumstances shall exceed the Price of the Goods and/or Services.
- 22.7 The Customer shall not be entitled to set off against, or deduct from the Price, any sums owed or claimed to be owed to the Customer by Gender Genie nor to withhold payment of any invoice because part of that invoice is in dispute.
- 22.8 Gender Genie may license or sub-contract all or any part of its rights and obligations without the Customer's consent.
- 22.9 These Terms shall prevail to the extent of any inconsistency with any other document or agreement between the Customer and Gender Genie.

2 WHAT INFORMATION DOES GENDER GENIE COLLECT AND HOW DOES IT USE IT?

- 2.1 Gender Genie may collect anonymous information when you interact with our Website such as your browser name, IP address, device type, operating system and web log information. Such information does not identify you personally, and we only use this information for statistical purposes and to improve the contact and functionality of the Website, to better understand our users and markets, and to improve our services.
- 2.2 Gender Genie may use cookies to identify your computer on your server and so that Gender Genie can track your use on the Website. In some instances, cookies may collect and store personal information about you. We may use cookies to recognise you as a user of the Website, to customise our services and advertising, and to collect information in order to alleviate the risk of fraud and illegal conduct. You may set your browser to refuse cookies, or to alert you when cookies are being sent. However, if you do so please note that some parts of the Website may not function properly.
- **2.3** When you purchase goods from us (in person, through our website or otherwise), Gender Genie may collect:
 - (a) your name;
 - (b) you and your partner's birth dates;
 - (c) your contact information including an address for delivery, billing address, email address, and telephone number;
 - (d) your demographic information such as postcode, preferences and interests; and
 - (e) other information relevant to customer surveys and/or offers.
- 2.4 Gender Genie may also collect personal information directly from you in circumstances where you make direct contact with us by telephone, in writing, or via our website. Gender Genie will



only use personal information collected in this manner for the purpose of communicating with you or otherwise in accordance with the purpose for which you provided your personal information.

 - (e) biometric templates.

5 STORAGE OF INFORMATION
